- 5. Health Inspector's report: COC issued at 0 Lafayette Dr after field removed and correctly installed. Berkshire Septic issued 2024 license for septic hauler, Issued 2024 license to McKnight Land for septic installer, Well permit issued 17 Curtain Rd, Sanitary Septic issued 2024 license for septic hauler. No update on 55 E Windsor Rd hogweed.
- 6. The Alliance Inspectional Services contract was discussed for the FY 2025 which includes an increase of \$462 this year. In an email from Ed he mentioned 2 new inspectors were hired one dedicated mainly for housing issues and one for food inspections. A motion was made, seconded and all in favor to recommend acceptance of the F 2025 Inspectional services contract. Val also stated she prefers to continue to have a weekly office hour for accountability. She will gather the data needed for the annual report. "and any other applicable statuary authority", the board approved in the motion to not change page 4 section (4) after explanation by Val the relevance of this item. The issues for further discussion include page 11 regarding water testing and Val will send a copy of the Egremont well regulations for comparison and page 16 Val will get select board approval to discuss with town counsel their comments regarding penalties and fines and report to the board at the next meeting.
